Text in WORD - Letter Arial, size 11 Margins Superior and left-handed of 2.5 cm., low and right of 2 cm., in leaf size A4, interlines 1,5.

Only one paper or work may be submitted by each author. Two papers/works may be submitted if there are several authors. The

papers/works have to be original and unpublished. The organizers will notify opportunely to the interested parties on the acceptance of these papers/works, as well as when they will be able to present their paper/work in the Congress schedule. The decision of the Scientific Commission will not be subject to appeal.

All workshops shall be both theoretical and practical.

#### **GUIDELINES** for the presentation of **POSTERS**

The organizers will notify opportunely the interested parties on the acceptance of the posters. The evaluation of the Scientific Commission will not be subject to appeal. Authors will be given a specific time and place to show and explain their posters to all interested in them. A prize consisting of books in Spanish will be granted to the best poster.

Title font shall be no less than 2.5 cm high. The body of the poster shall include: Introduction with objectives or information related to the presentation, studied population, materials and methods used, results, conclusions and/or recommendations.

Tables, illustrations and photographs of the presentation shall be understandable and distributed sequentially according to the presentation.

All illustrations shall have a caption below.

High-contrast fonts are suggested for printing as the poster shall be readable from a distance of 150 cm.

Lightweight material is suggested for the poster, for easier hanging.

Size shall not surpass 150 cm height and 90 cm wide. Author shall be solely responsible for hanging the poster.

Removal of the poster shall be done in the date and time appointed by the Scientific Commission.
